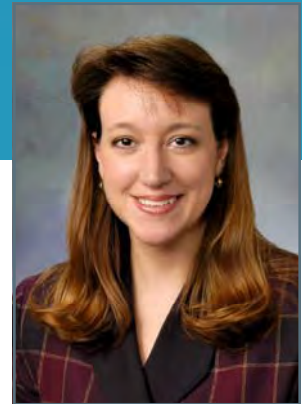

Here are some tips on how to price your donations.

- Cookies, Brownies, and Bar Cookies \$1.00 - \$2.00 depending on their size
- Cupcakes, Muffins, and Larger Cookies \$2.00 - \$3.00
- Small Loaf Breads \$5.00
- Cakes & Pies \$10.00
- Candies \$1.00 - \$2.00/bag

By adding cute gift tags, ribbon, or other decorations, the item can be turned into a gift and thus will bring a higher price. If the baked good contains ingredients that are expensive such as nuts or involves a lot of time to prepare, it can also justify a higher price. If you bake a recipe by a local celebrity or from a well-known person or place in our community, that too can also make for a popular baked item. There are some types of items such as cookie ingredients in a jar, or homemade granola in decorated jars that can be prepared ahead of time. Please remember not to bring items that need refrigeration. Some people might buy gluten free items or sugar-free items.

We also hope to add a spark of fun by having an hourly baked goods chance drawing for different donated items.

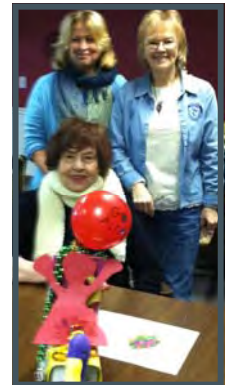
SPRING ORIENTATION/REORIENTATION TEAMS BUILD MARDI GRAS FLOATS!

**OVERNIGHT BLUEBERRY FRENCH TOAST SERVED AT ORIENTATION/REORIENTATION**

From the kitchen of Lynn Solomon

- 1 loaf good Italian Bread, torn into bite size pieces
- 14 oz. Cream Cheese - room temp
- 1/3 cup Confectioners' Sugar
- 4 cups fresh Blueberries
- 10 Eggs, beaten
- 2 cups Milk
- 1 tsp. Vanilla Extract
- 1/3 cup Maple Syrup

Sauce:

- 1 cup White Sugar
- 2 tbsp. Cornstarch
- 1 cup Water
- 2 cups fresh Blueberries
- 1 tbsp. Butter

1. Spray heavy glass 9 x 13 baking dish with butter non-stick cooking spray. Cream together, cream cheese & confectioners' sugar. Arrange half the bread cubes in the dish, and top with cream cheese mixture. Sprinkle 2 cups fresh blueberries over the cream cheese, then top with remaining bread cubes.
 2. In a large bowl, mix the eggs, milk, vanilla extract and syrup. Pour over bread cubes. (You may need to push bread back down into the liquid a bit.) Cover and refrigerate overnight.
 3. Remove casserole from refrigerator about 30 minutes BEFORE baking. Preheat oven to 350 degrees.
 4. Cover and bake for 30 minutes. Uncover and continue baking up to 30-35 minutes longer, until center is firm and surface is lightly browned.
 5. In medium saucepan, mix the sugar, cornstarch and water. Bring to a boil. Stirring constantly, cook 3-4 minutes. Mix in the remaining 2 cups fresh blueberries. Reduce heat and simmer 10 minutes until the blueberries burst. Stir in butter and pour over bread.
- * You may wish to double the recipe for the sauce and serve extra sauce on the side.
- * I used frozen blueberries and they worked just fine.

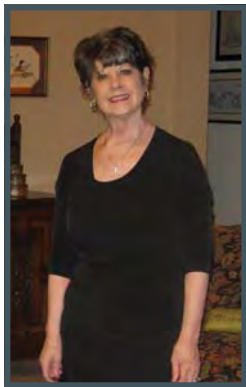

CHILI AND TOTE PARTY PLUS SO MUCH MORE!

After much discussion and many phone calls, Marsha Peters, Co-Chair of the Outreach Committee, obtained a contact at New Beginnings, an abused woman’s shelter in Garland. The Committee decided on using what was left in our budget to buy toiletry items and maybe a blanket to give to women when they enter the shelter.

We were able to buy enough items to fill 50 Target Recyclable bags and fill each one with a blanket, shampoo, conditioner, razor, deodorant, manicure kit, toothbrush, toothpaste, comb, hand sanitizer, a bar of soap, a pair of socks, and a washcloth. New Beginnings told us that by providing 50 bags we would be helping 50 women as they enter the shelter. Many of the clients that come to the shelter arrive with nothing but the clothes they are wearing, or at best very little in the way of personal items.

The Committee asked the club to volunteer time to put together the bags and to bring a donation of a bottle of lotion to complete the items needed for the bags. Brenda Duckett graciously provided her home as the assembly place. The Committee decided to make it a party and provide food for all who participated. We had a chili dinner, deliciously made by our hostess Brenda. Others on the Committee brought all the other items needed and Jean Stuart made the MOST delicious Texas Chocolate Sheet cake to top off our hard work. A few brought wine and the fun began.



Bonnie Perry volunteered to make coloring book sheets to assemble into coloring books, members brought crayons, and our President Kimberly Kierce designed a cover. So, while some of our volunteer members were stuffing the bags for the moms, others were assembling the coloring books to take for any children that might come to the shelter.

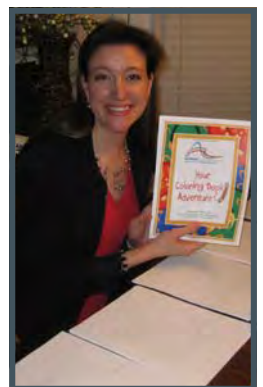
Jane Tucker, bless her soul, brought a case of lotion, a doggy nebulizer for children with asthma, and a case of diapers, all from Neil Kocranci of Medline Industries, Inc. He is one of her company’s distributors. In addition to that, almost everyone that came to help with the assembly of the bags and coloring books, brought bottles of lotions and lots of crayons. We are a very generous group! We ended up with 32 large bottles of lotion, plus sixty purse size bottles. Dr. Reid Slaughter, DDS, Sue McElveen’s dentist, from Lakewood Family Dental Care, donated the 50 toothbrushes and 50 tubes of toothpaste.



After all assembly was completed and all the cake was devoured, we loaded up Sue McElveen’s car to the brim. We needed an extra car, so Genevieve Hamulak volunteered to help transport the rest with Sue to the New Beginnings location on Friday, March 1.

Sue and Genevieve met up and called for directions to the center. We had a great tour of the facility, learning much about their operations and left there feeling grateful that there is a place like New Beginnings for those in need because of abuse. The

facility holds up to 33 people (they can house up to 36 if there are small infants that can sleep with their mothers). New Beginnings is funded primarily by grants and donations. The clients that are living there are the ones that clean the house, cook the food, and do other chores as deemed necessary. They have a chores list and all must do their part. A large part of their food is bought at the North Texas Food Bank, plus they get donations of fresh fruits and vegetables from local Tom Thumb stores.

New Beginnings provides parenting classes, group discussions that help the clients to understand the circle of violence, how to stop the abuse and prevent it from recurring in the future. They also provide the clients with job leads, job searches, etc. They have a wonderful children’s playroom where they have a male mentor that comes 5 days a week to work with the children. He shows them that not all males are violent or abusive and helps them regain trust in men. This service is provided by a grant from the Jason Witten Foundation. Jason was a victim of parental abuse when he was a small child. Clients and their children can remain at the shelter for up to 30 days, after that they are routed to the Outreach Center where they can receive semi-permanent housing for up to two years in local apartment buildings.

We left knowing that we had helped a wonderful organization. A big thank you to Isabel Camacho, Shelter Coordinator, and Katie who gave us the tour. This was the perfect way to end our Committee’s year. Thanks to all of you wonderful women that helped with this project. Altrusa is truly an organization that gives back to the community.

VERA'S BIRTHDAY CELEBRATED AT ABILITY HOUSE

Joining us in celebrating Vera's birthday on February 23, were her sister and husband, and Bill Knudsen, President and CEO of Ability Connection Texas (ACT). We will have two parties at Ability House in March: on the 2nd, for Kathleen's birthday, and on the 30th for and Easter celebration.

We adopted Ability House in 1995. Altrusans visit the residents of Ability House to celebrate birthdays and holidays. The birthday parties are usually conducted on a Saturday afternoon. Volunteers bring cake, beverages and a gift from the club. Residents enjoy our company and all members are encouraged to attend.

ACT provides caring, family-style living environments for adults with disabilities through its residential services program. ACT currently operates seven homes throughout the North Texas area. These homes, sometimes referred to as group homes, allow individuals with disabilities to live with as much autonomy and independence as possible.

ACT's residential homes are staffed 24 hours a day. When residents are home, at least two care professionals are there to assist residents with personal care activities such as, feeding, bathing, and personal hygiene, as needed. During sleeping hours, at least one care professional is awake and on duty. ACT's care professionals also clean and maintain homes, cook meals, and provide personal assistance based on each resident's needs and abilities.

INTERNATIONAL WOMEN’S DAY TO BE OBSERVED ON MARCH 8

The first International Women’s Day occurred on March 19th, 1911. The inaugural event included rallies and organized meetings in countries all around the world. The date commemorated a day in 1848 when a Prussian king promised to introduce voting for women. Even though he failed to keep his promise, it at least gave hope for women to gain equality. Then, in 1913, the International Women’s Day was moved to March 8th. In 1975, the United Nations drew global awareness of concerns regarding women by calling for an International Women’s Year and the UN General Assembly decided to continue this worldwide phenomenon with events in many countries on every March 8th aimed at helping nations eliminate discrimination against women.

This year, as part of the United Nations celebration of International Women’s Day, the UN Women will launch “One Women: A song for UN Women”, a song featuring more than twenty artists from across the globe. This song is a way to lyrically call for change and celebrate acts of courage and determination by ordinary women. The “One Women” song aims to become a rally cry to inspire listeners about the mission of the UN Women and help others join in the drive for women’s empowerment and gender equality. 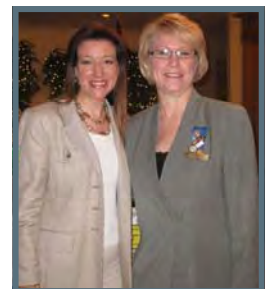
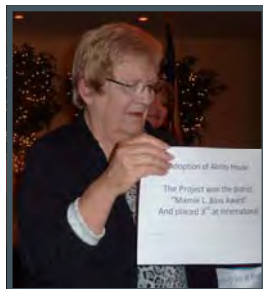
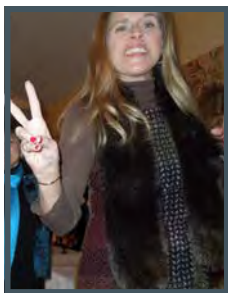

INTERIM ASSOCIATION DIRECTOR APPOINTED

In October 2012 President Dona Garretson advised the District Governors that Executive Director Harriet Lewis had left employment with Altrusa effective October 22. I trust this information made its way to you through DSBs and club newsletters.

Since that time President Dona has volunteered her time and expertise to the International Office by traveling to Chicago periodically (on average a week or two a month) and maintaining regular communication with the staff via telephone and email. She has handled all administrative and supervisory responsibilities of the Executive Director that are not in conflict with her role of International President.

The Personnel Committee met on February 7, 2013 to evaluate the current status regarding the vacancy in the position of Executive Director and came to several conclusions, some in consultation with the Finance Committee who also met that day. The conclusions were:

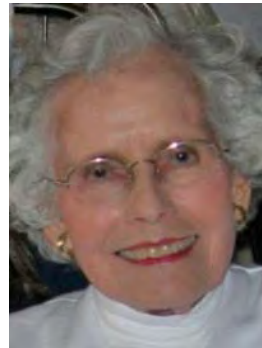
1. The International Office has been operating effectively in the absence of an Executive Director under the volunteer guidance of President Dona Garretson who negotiated a new lease for office space at extremely advantageous rates; initiated a new contract and a renewed relationship with Doc Morgan; helped the organization reduce expenses in a number of areas and worked with Altrusan Beth Blair to develop a plan to celebrate Altrusa's 100th anniversary to name a few of her recent activities
2. Asking Dona to continue as a volunteer takes advantage of her generosity and love of Altrusa and at times has her working full time as a volunteer for the International office plus carrying out her responsibilities as International President. In addition she will be assisting the office as it prepares for several major projects including the International Convention
3. With the continuing decline in income due to membership loss Altrusa International, Inc. can no longer afford the services of a full-time Executive Director and the position must be replaced with a new part-time position Association Manager.
4. Hiring a part-time Interim Association Manager would be a good way to determine the key functions that are necessary in this a position and the appropriate level of part time employment
5. Dona Garretson would be an excellent choice for the Interim Association Manager at half-time if she is willing to continue until after the Convention at which time the Personnel Committee and Board would reassess the situation and determine whether to continue with an Interim or a hire a Permanent Association Manager.

The Board of Directors at its mid-year meeting on February 8th offered Dona Garretson the position of Interim Association Manager effective retroactively from January 1, 2013 through July 31, 2013 which she accepted.

HUMAN TRAFFICKING IN RICHARDSON—COULDN'T HAPPEN

HUMAN TRAFFICKING IS SLAVERY IN THE MODERN AGE



Back in the late '90s, early 2000s, I noticed newspaper announcements of programs being put on at various elementary schools in Garland, Plano and Richardson. A group called Zambia a Cappella would put on concerts at the schools. One of my favorite singing groups at the time was Ladysmith Black Mambazo. They were the most wonderful a cappella singing group from South Africa. They had made appearances on Sesame Street. If Zambia a Cappella was even half as good, they would be fantastic singers.

My son Paul was in RISD's Mohawk Elementary school. I was very much anticipating Zambia a Cappella coming to Mohawk and, sure enough, a concert by the group was shortly announced to be held after school.

Parents were given information about the group. It was group of young Zambian men who were being sponsored in the U.S. by a church group out of Whitesboro, TX. Most of the young men were supposedly orphans. The advertised goal of the sponsors was to have the young men sing and earn money to go to college in the U.S. Also, another goal was to build a school (for orphans, of course) in the district of Zambia that the young men came from, using part of the proceeds from the concerts. (The concerts were free. Money was generated by cassette and CD sales, poster sales and other merchandise.)

I was very concerned about the group, because I worried that the young men might be taken advantage of. I determined to keep my eyes out at the concert.

But at the concert, which Paul and I enjoyed very much, I looked carefully at the singers. While they were singing, they looked very joyful. They had good eye contact with the audience and seemed at ease. As they sang and danced their way out of the venue, I tried to make eye contact with each one. But they kept their eyes down. They immediately boarded the bus that they came on—no mingling with their new fans.

However, there was a sales table that did a rush business. We bought a cassette tape for me. Paul loved the group very much and wanted a poster. My misgivings could not be supported by what I had observed, so we put the poster up in Paul's room. And I enjoyed the cassette tape a lot.

Later on, a small article appeared in the Dallas Morning News to the effect that a couple in Whitesboro were being investigated by Federal authorities for human trafficking of youths from Zambia. Of course, details were few and there was no follow-up. My fears were realized. But for years I did not find out anything more.

One day in a doctor's office, I picked up a *People* magazine. One of the articles was about a former member of Zambia a Cappella. He had been adopted by an American couple and was going to college. He told some of what the young men had been subjected to while under the control of Keith Grimes and his wife, who were the "sponsors" of Zambia a Cappella.

I urge you to read the rest of the story by clicking on the links below. If something seems to be too good to be true, it just might be. I do not know what I could have done if somehow one of the young men had indicated that he needed help at the Mohawk concert. But I hope I would have done something. Of course, these youths were living in fear, so they did not reach out to anyone.

The main lesson is that human trafficking can be carried out pretty openly, even in communities like Plano, Richardson and Garland.
