**INTERNATIONAL DAY OF FAMILIES IS CELEBRATED MAY 15**

The United Nations has observed every May 15 as International Day of Families since it was proclaimed such by the UN General Assembly in 1993. It is meant to reflect the importance the international community attaches to families and provide opportunities to promote awareness of issues relating to families and increase the knowledge of the social, economic, and demographic processes affecting families.

This year's theme for International Day of Families is "Advancing Social Integration and Intergenerational Solidarity." The goal of the theme is to focus on all social groups and individuals in the political, social, cultural, and economic structure so they can participate in decision making processes and have improved access to education and economic advancement. Integration into society is essential in the creation of "a society for all" by promoting intergenerational solidarity among individuals in multigenerational family networks and among the

different age cohorts in larger communities. The policies and programs being created are intended to foster solidarity, promote social cohesion, share responsibility and understanding between generations not only at the family level, but at community and national levels to increase positive relationships across age groups and strengthen ties between family and community members.

Research indicates that intergenerational family bonds remain strong. Family members still assist one another in financial support as well as grandparents helping in the daily care of younger children to allow their parents to work. The success of social integration and inclusion efforts depends on the effectiveness of public policies and the support of local communities to participate in and engage people in planning, implementation, monitoring, and evaluating policies and programs designed for social inclusion.



## Committee Report

### **ALTRUSA RICHARDSON DONATES TO USO TO MARK UN DAY OF FAMILIES**

To celebrate both May 15, UN International Day of Families, and May 11, Military Spouse Appreciation Day, the International Relations Committee has donated \$150 to the USO to be used in two programs that are designed to keep deployed military personnel connected with their families.



The first program selected is called Full Circle Home. The program originated in 2006 when Vickie Durfee thought of it as a way to help her deployed son get a gift to his girlfriend. So many of our service men and women are away from home and feel the need to reach out to their families with a care package to let them know how much they love them and miss them, especially at Christmas and Mother's Day. It enables our heroes to be heroes by allowing them an opportunity to send back love to their wives, fiancés, girlfriends, and mothers in the form of a gift package especially orchestrated for them. Last year, First Lady Michelle Obama and Dr. Jill Biden joined dozens of Congressional spouses to assemble over 2,000 Mother's Day gift boxes for Full Circle Home. The boxes contained perfume, lotions, gift cards, a charm bracelet, and a hand-written note from the troops to the women in their lives.

The second program similar to Full Circle Home is called Operation USO Care Package. This program is designed to have a care package sent—not to the deployed military personnel but to the family to help them stay connected. Troops headed overseas write a note in a special journal which is packed in a “care package” with other useful items like prepaid calling cards, disposable cameras, and gift certificates for groceries and tutoring services. The package arrives home several weeks after the service member is deployed, reminding the family of how much they are loved.

Altrusa recognizes the importance our military families play in keeping our Armed Forces strong and our country safe. It is hoped that our contribution will help show our support for our Armed Forces and their families.


VE Day or Victory in Europe Day is Wednesday May 8. It was on May 8, 1945, that Germans throughout Europe surrendered to the World War II Allies.

**TERRACE ELEMENTARY 4TH GRADERS CHOOSE HEIFER INTERNATIONAL GIFTS**


Holly Baxter's 4th grade class chose the country and animals to be sent to Heifer International. On April 30, 2013, Mary Beth McLemore and Barbara Berthold visited the class for the International Relations Committee. The students, who had read a little about Heifer when studying for the Stars Test, were excited to do this special project according to the Mrs. Baxter.

First, Mary Beth talked to them about Heifer and her experiences on a farm, which taught her about the importance of the Heifer Project. Many of the students shared their farms adventures too. Then Mary Beth explained to the class about Altrusa and the \$150 Altrusa wanted to send to Heifer. Information sheets were handed out and students divided into groups to make decisions on how to spend the amount, which, to them, seemed to be a lot of money.

Each child was given a butterfly, which they knew represented Heifer. These pipe cleaner crafts were made by Rose Daughety' seniors as part of the decorations for our Twelve Step Heifer Program at the March Dinner Meeting. As the students worked to come up with an animal or animals, colorful butterfly rings, bracelets, and wands circulated with them. A lot of individual knowledge was shared, questions were asked, and then decisions were made.

Ms. Baxter wrote on the board all the different suggestions of which countries and what animals to buy for them. Groups explained their reasons for their choices. Four countries, Mexico, Thailand, Haiti, and Nepal, were picked but the majority decided on Mexico and Thailand. It was a definite that all students wanted to buy lots of animals and not just one so after discussion and lots of reasoning the vote was \$20 for a share of Sheep, \$20 for a share of Seedlings, a Trio of Rabbits for \$60, Honeybees for \$30 and Flock of Ducks/Geese for \$20.

Each child was then given a Heifer flag or a sparkling butterfly to show that they were ambassadors of Heifer International. Again, these items were recycled from the March table decorations. Mary Beth and Barbara enjoyed Ms. Baxter's well-run, smart class and both hope Altrusa will continue to encourage sharing of projects with our adopted school Terrace.



**ASAPP: ALTRUSA SISTERS ADOPTION PET PALACE**

The Seniors Committee voted earlier this year to use their remaining funds for a “senior pets” project. It was not exactly clear whether the “senior” applied to the pets or the people, but funds became available at the same time an animal-related need was identified.

**First, the funding.**

Carolyn Swanson and her mother, Ernestine, both retired from companies with big hearts who turn volunteer hours into money for nonprofits in which their employees or retirees volunteer. The companies are Texas Instruments and PNM Resources. (Verizon has a similar program; does your employer??) Ernestine’s \$100 grant and Carolyn’s \$1000 grant will be given to AnimaLuv, a local non-profit founded in 2004 by former Altrusan Peggy Thorburn. AnimaLuv provides an avenue for donations and volunteer efforts benefiting the City of Richardson Animal Shelter.



**And then more funding.**

The Club did not need to purchase a President’s Pin for Kimberly Kierce, because she received her pin as a gift from a friend. Kimberly has requested that \$300 of the funds budgeted for her pin be given to AnimaLuv. (Thanks to Mary Beth McLemore, for setting a precedent in such a situation! She used her “pin money” to have an Altrusa Tree planted at the Richardson Woman’s Club.)

**Second, the project.**

There will be a new adoption/video room at the Animal Shelter. There will be continuous video on the City website, showing available animals (mostly cats) climbing cat trees and doing other cat things.

**Third, the publicity.**

Our sponsorship of the “Altrusa Sisters Adoption Pet Palace” will be shown on a plaque near the door to the room and on scrolling text along the bottom of the streaming video from the Altrusa Sisters Adoption Pet Palace!




**AWCLS WILL DISCUSS *SOUTH OF BROAD* IN MAY, *THE CHAPERONE* IN JUNE**

A few very adventurous souls met on Monday, April 22 to discuss *Empire of the Summer Moon* by S.C. Gwynne. Thanks to Susan Frensley who stepped up to lead an interesting and informative discussion.

This was our history book selection for the year. The book traces two astonishing stories. The first traces the rise and fall of the Comanche, the most powerful Indian tribe in history. The second entails one of the most remarkable narratives ever to come out of the Old West: the epic saga of the pioneer woman Cynthia Ann Parker and her mixed-blood son Quanah, who became the last and the greatest chief of the Comanche.

Our selection for May 20 is *South of Broad* by Pat Conroy. Leopold Bloom King has been raised in a family shattered—and shadowed—by tragedy. Lonely and adrift, he searches for something to sustain him and finds it among a tightly knit group of high school outsiders. Surviving marriages happy and troubled, unrequited loves and unspoken longings, hard won successes and devastating breakdowns, as well as Charleston, South Carolina’s dark legacy of racism and class divisions, these friends will endure until a final test forces them to face something for which none of them are prepared. Spanning two turbulent decades, *South of Broad* is Pat Conroy at his finest: a masterpiece from a great American



writer whose passion for life and language knows no bounds.
