Eligibility

District Bylaws Article XI: Officers; Section 1. Elected Officers

(d) No more than two (2) elected officers shall be from the same Club during any term.

(i) Eligibility Requirements

To be eligible for election to the District Office, members must be, at the time of the nomination and election an active member in good standing. To be eligible for election to the office of Governor-Elect, the candidate shall have previously served a full term as a member of the District Board.

To be eligible for election to any District Office other than treasurer, a person must have completed a full term as Club President or be serving as Club President at the time of the election.

To be eligible for District Treasurer, a person must have completed a full term as Club President or Club Treasurer or be serving as the same at the time of the election and also must have general accounting knowledge or experience.

In Memory of... Carolyn Swanson Nordmeyer




