Warm pajamas are considered a luxury, as basic supplies like toothpaste and soap are the priority.

November Dinner Meeting **Refugee Services of North Texas** By Robin Smith

Lily Heine from Refugee Services of Texas was the featured speaker for the November Dinner meeting program. Refugess Services of Texas (RST) was founded in 1978 as a social-service agency seeking to welcome

refugees and other displaced people to Texas and to support them in integrating and thriving in their new communities. Guided by the



principles of human dignity and compassion, RST has welcomed hundreds of refugees, asylees, and victims of human trafficking to Dallas through providing core services of resettlement case management, employment services, intensive case management, and legal aid.

Lily completed her undergraduate degree at Baylor University in International Studies with an emphasis in the Middle East. After graduating, she interned at the International Rescue Committee Dallas alongside the Case Managers handling the first ninety days of the U.S. Refugee Resettlement Program. In the summer of 2016, she moved to the Middle East to work at an NGO as a Community Development Liaison in the surrounding area of the Za'atari Refugee Camp. Lily recently accepted her assignment at Refugee Services of Texas through the Americorps Service Program. She is a fluent Arabic speaker and works diligently to connect the Dallas community to RST in order to make Dallas a welcoming and safe city for our new neighbors.

It was an extremely enlightening program and we had a robust question and answer session as Lily helped us understand more about the current refugee situation in our area and how we can help.

Sophomore Sisters Committee Follow-Up Report Make A Difference Day at Café Momentum By Nancy Rohm



On the evening of Make A Difference Day, Saturday, October 28, 2017, twenty-two Richardson Altrusans, guests, and spouses ate dinner at

Café Momentum in Dallas in support of their program. Altrusa International asked clubs to celebrate Make A Difference Day (MaDD) with something "vocational" this year and the Sophomore Sisters Committee decided on Café Momentum as the MaDD project. (The Sophomore Sisters are all members who became Richardson Altrusans during the 2016-17 Altrusa year.) The Café management told us the most helpful thing we can do is to come there and eat, allowing the interns to have experience cooking, serving, cleaning-up, etc. Additionally, Richardson Altrusans presented the Café's Executive Chef with a \$250. check from our Foundation. Café Momentum is much more than a high-end restaurant. It is a 501 (c) (3) non-profit that works with the Dallas County Juvenile Justice System to train post-release non-violent juvenile offenders in the skills that will allow them to run a restaurant. "Youth are released from detention into the sheltered environment of Café Momentum's postrelease program" where the young men and women participate in a 12-month paid internship program. They are supported by case managers, who help them develop leadership, social and vocational skills, while exercising and practicing their new skills by working side-by-side with established chefs. That evening the Executive Chef, Chad Houser, shared with us that he takes the interns on outings. One example is a field trip to various farms where the interns taste carrots grown in different soils, learning how food grown in one soil can taste different from the same food grown in another soil. The purpose is to develop the intern's palates as chefs.

The evening was delightful. Those in attendance had a wonderful time and enjoyed a delicious meal while engaging with the young servers. Seniors Committee **Appletree Auction Fun!** by Robin Smith

Altrusa Accent – 2 November 2017 **Meaning of Altrusa** By Cat Zultner

When I joined Altrusa, I was looking for something – a way that I could personally make a difference in my community by any definition: my neighborhood, my city, my state, my country or my world.

I did a little research on the "Altruism" side of the "Altrusa" equation and found an interesting book called "Doing Good Better – Effective Altruism and How You Can Make a Difference" by William MacAskill. I found a couple things that rang very true for me. From the book:

For almost all of human history – from the evolution of Homo sapiens two hundred thousand years ago until the Industrial Revolution 250 years ago – the average income across all countries was the equivalent of two dollars per day or less. Even now, more than half of the world still lives on four dollars per day or less. Yet, through some outstanding stroke of luck, we have found ourselves as the inheritors of the most astonishing period of economic growth the world has ever seen, while a significant proportion of people stay as poor as they have ever been.

....We live at a time in which we have the technology to easily gather information about people thousands of miles away, the ability to significantly influence their lives, and the scientific knowledge to work out what the most effective ways of helping are. For these reasons, few people who have ever existed have had so much power to help other as we have today.

Sometimes we look at the size of the problems in the world and think, "Anything I do would be just a drop in the bucket. So why bother?" But, in the light of research...that reasoning doesn't make sense. It's the size of the drop that matters, not the size of the bucket, and if we choose, we can create an enormous drop..... That we can't solve all the problems in the world doesn't alter in any way the fact that, if we choose, we can transform the lives of thousands of people. Here's what I gleaned from that passage and why I think my personal involvement in Altrusa makes a difference:

- 1. It is NOT about solving everything for everyone. It IS about doing what I can, where I am and always looking forward.
- It is NOT about the individual size of each gift, but working together to make the biggest "drop" in whatever bucket we choose to fill. With money, time, love, etc. – all our contributions make a difference

Thanks for allowing me to be part something bigger than myself and room to make a difference in our world.

UN Day – December 10 Universal Declaration of Human Rights Turns 70

Human Rights Day is observed every year on 10 December – the day the United Nations General Assembly adopted, in 1948, the Universal Declaration of Human Rights. This year, Human Rights Day kicks off a year-long campaign to mark the upcoming 70th anniversary of the Universal Declaration of Human Rights, a milestone document that proclaimed the inalienable rights which everyone is inherently entitled to as a human being -- regardless of race, color, religion, sex, language, political or other opinion, national or social origin, property, birth or other status. While its promise is yet to be fully realized, the very fact that it has stood the test of time is testament to the enduring universality of its perennial values of equality, justice and human dignity.

The Universal Declaration of Human Rights empowers us all. The principles enshrined in the Declaration are as relevant today as they were in 1948. We need to stand up for our own rights and those of others. We can take action in our own daily lives, to uphold the rights that protect us all and thereby promote the kinship of all human beings.
