
July 17, 2022 Show time 2pm at the Eisemann Center, 2351 Performance Dr in Richardson.

Altrusa Grants Available to Area Nonprofits

Altrusa International of Richardson announces that applications are now being accepted for grants to qualifying area non-profits for the 2022-2023 grants cycle. Grants typically range from \$1,000-\$1,500. Monies provided by Altrusa grants must be used by awardees for specific projects benefitting the community and must be disbursed no later than May 31, 2023 unless otherwise reported.

A fillable application form and submission instructions are available on the Altrusa website at <u>www.altrusarichardson.com/grants</u>. Additionally, reminder letters are being sent to 501(c)(3) recipient organizations who received funding last year.

Submission deadline is August 31, 2022. Applications will be reviewed by the Grants Committee then its funding recommendations will be submitted to the Foundation which will make the awards. Grantees will receive notification by October 31, 2022. 
CHOOSE KIND LIBRARIES

Difference between the Altrusa Association (clubs) 501(c)(4) and the Foundation 501(c)(3).

The Altrusa International Foundation was established in 1962 as the charitable arm of Altrusa International. While both the association (Altrusa International) and the Foundation are non-profits and do not have to pay taxes on their income, the Association is not a charity and the Foundation is. Thus, gifts to the Foundation are tax deductible, while gifts to the Association are not.

The Association is a 501(c)(4) tax exempt social welfare organization, while the Foundation is a 501(c)(3) charitable organization.

Likewise, Altrusa clubs are part of the Association and are not charitable organizations; they work to improve their communities through service and operate to promote social welfare. Clubs are 501(c)(4) social welfare organizations. Clubs may have affiliated local club foundations, many of which share the tax exemption of the Foundation and report regularly to it; these local club foundations are charities, also known as 502(c)(3) organizations.

These foundations work closely with their clubs to encourage charitable donations which are used to fund club community service projects. Charitable donations to a club's foundation may only be used for service projects and may not go to the administrative activities of the club.

Clubs that do not have a local foundation and wish to form one may contact the International Foundation for information and assistance.
